Charges to Memorials were \$200 (Medea \$100 and church rental \$100) Balance \$4697. No charges to Education Grants. Balance \$854.

We went over the line items for the Projected Budget for 2023.

We take in less than we pay out. We don't spend too much, so we can protect the money for the future.

Ideas to reduce costs: Mario asked about a group insurance policy. (Our cost is \$500/yr.) It was suggested we get rid of the land line phone. We will pay less national dues because we have less members.
